PRESIDENT'S MESSAGE By Ann Devlin

I am pleased that HBO recently chose to air the documentary <u>Gasland Part II</u> by Oscar-nominated director Josh Fox. <u>Gasland Part II</u> pulls back the curtain on the fracking industry that's threatening our water, our air, our communities, and our climate – and shows how a grassroots movement is fighting back.

For those of you not as familiar with the term "fracking" as you would like to be, fracking is a term used to refer to oil and gas development generally. It is hydraulic fracturing or industrial gas drilling whereby fluid is injected underground at high pressure to fracture rock and release oil or gas trapped inside the formation. Proponents of hydraulic fracturing point to the economic benefits from the vast amounts of formerly inaccessible hydrocarbons the process can extract. Opponents point to potential environmental impacts, including contamination of ground water, depletion of fresh water, risks to air quality, the migration of gases and hydraulic fracturing chemicals to the surface, surface contamination from spills and flow-back, and the health effects of these.

Many environmentalists believe that fracking is a dangerous way of getting oil and gas and a shortsighted energy strategy that is poisoning our air and water, and is on its way to jeopardizing the health of millions of Americans. They content that fracking fluid – which is laced with toxic chemicals that have not been fully tested or disclosed to the public – may be released into the environment through inadequate waste disposal, leaks, spills, and other accidents presenting serious risks to public health and the environment.

PRESIDENT'S REMARKS AT 2013 ANNUAL DINNER

Reprinted for those members not able to attend the Annual Meeting & Dinner

President –Elect Devlin delivered the following message at SAVE's 40th Annual Meeting and Dinner on June 12, 2013:

"In May, for the first time in at least 3,000,000 years, the level of heat-trapping CO2 in our atmosphere rose above the, once unimaginable, barrier of 400 parts per million. While efforts to reverse the direction and move the planet towards a safer 350 ppm have been building momentum, they are not enough and not happening fast enough. Most scientists believe that at 450 ppm, the results would be catastrophic and irreversible, and at the present rate, we could arrive at 450 ppm in just 20 years."

"It is up to each of us to do what we can individually, as a community, and as part of the Global Network to keep the level of CO2 in the atmosphere from climbing higher. We can redouble our efforts to reduce, reuse, recycle. We can cut back on our use of fossil fuels in our daily lives. We can look at alternative energy programs and have our houses energy assessed to see what changes can be made. And we can and should petition our representatives in government to work aggressively toward global solutions. It has never been more important to "Think Globally and Act Locally" and we owe it to our grandchildren to do what we can to join other activists both locally and around the world to help take the necessary steps to transition the global economy away from fossil fuels and into renewable energy, energy efficiency, and sustainable farming practices in all sectors (agriculture, transport, manufacturing, etc.)."

I-95 ROADBED UPDATE

Goodwin, Secretary and Editor: 781-233-8054 Representatives from the Department of Environmental Protection (MassDEP) and the Department of Conservation and Recreation (DCR), joined by approximately fifteen Saugus residents as well as town attorneys and engineers, did a site walk-through of the abandoned I-95 roadbed area adjacent to Route 107 in mid-June. The roadbed was part of a proposed Interstate 95 extension that was to cut through the marsh area. But after the project started in the early 70's, it was abandoned and a large mound of sand was left in the marsh. DCR originally approached the Town last summer about removing as much as 350,000 cubic years of sand for the purpose of restoring Winthrop Beach. The Saugus Conservation Commission met over a number of months and approved the project in April with about 230,000 cubic yards of sand slated for removal. Approximately 20 Precinct 10 residents filed an appeal of that decision in May with the MassDEP, which led to the site walk-through. While the issue of ownership of the land is still being looked into, residents want to make sure they will get the best project possible with the least impact – and which includes restoration of the salt marsh. A MassDEP decision is expected sometime in the near future.

BOTTLE BILL UPDATE

The MA Sierra Club released the following press release earlier this month on July 3rd:

Legislature Drops the Ball, Rejects Bottle Bill Update

Today, the Legislature dropped the ball once again, as the final FY14 budget was reported out of the budget conference committee without the Updated Bottle Bill in it. The Senate had voted unanimously to include the Updated Bottle Bill in its version of the FY14 budget, and while the House never considered it in their budget, 76 members of the House are cosponsors of the bill. But when the budget conference committee--which meets behind closed doors and does not record individual votes--was finished resolving the differences between the House and Senate budgets, the Updated Bottle Bill was not included.

"The conference committee snatched defeat from the jaws of victory," commented Janet Domenitz, Executive Director of MASSPIRG. "The Updated Bottle Bill is wildly popular with the public, with over 100 organizations, with 208 cities and towns, with 350 small businesses. The Legislature had a chance to make this bill law and they ignored it."

The Updated Bottle Bill, which would add a nickel deposit to beverage containers such as water and sports drinks, has been pending in the Legislature for several years. The single most effective recycling tool in the state, the current bill, which has been on the books since the early 80's, reduces container litter by 80%. "As beach season gets underway, it's a dramatic reminder of how much litter and trash we could get rid of if we simply put that nickel deposit on more beverages," said Ryan Black of the Sierra Club, another Updated Bottle Bill supporter. "Our environment would be cleaner and healthier if we could recycle more of these plastic bottles which are trashing our ocean, our parks, and our open spaces," added Ken Pruitt of the Environmental League of MA. The coalition pushing this bill includes the League of Women Voters, the South Shore Recycling Cooperative, the Emerald Necklace Conservancy, and over 90 other local and statewide groups. The coalition will continue to vigorously pursue this long overdue reform.
