ATTENTION MEMBERS – REMEMBER NOT TO CREATE "MULCH VOLCANOS" DURING YOUR FALL PLANTING/CLEANUP

Save and the Saugus Tree Committee want to remind everyone that, as you do your Fall planting and cleanups, please be aware that too much mulch will kill trees and shrubs.

More than 2 to 4 inches is over-mulching. Also, the practice of piling up mulch around the trunk or stem in a "MULCH VOLCANO" can cause many problems for trees and could actually kill a tree.

Proper mulching practices include:

- Checking the depth of mulch. If 2 4 inches of mulch is already in place, just rake to refresh and break up mats.
- If mulch is piled against the trunk or stem, pull it back several inches so that the base of the trunk and stem crown is exposed.
- Only apply a 2 to 4 inch layer. Do not place mulch near the trunk. Mulch out to the tree's drip line or beyond.
- Keep mulch flat, not mounded, so that water will not run off.

And don't forget to give specific instructions to your landscaper!

The Tree Committee needs your help, and this is a great project for students to complete community service as a graduation requirement.

People are advised to wear work clothes and bring some work gloves, a hat, boots (as it may be muddy, and sunscreen/bug spray. If you have trowels, shovels or hoes, please bring them along.

DIRECTIONS to Tree Farm: take Jasper Street (off Central Street) then take a right, which is Cross Street (the sign says "to Auburn Street"). Bear left onto Auburn Street. The walk-through driveway is between 25 and 27 Auburn St. (Pioneer Sales Building), then walk down the driveway to right of building, over railroad tracks and follow dirt road to tree farm.

BOTTLE BILL UPDATE

Janet Domenitz, MASSPIRG Executive Director, recently reported the following in the MASSPIRG Fall 2012 Newsletter:

Bottle Bill Update Falls Just Short

Despite overwhelming public support for the Updated Bottle Bill – a commonsense recycling measure that would add the 5-cent deposit to beverage containers like water and sports drinks —the bill died in committee right before the legislative session ended on July 31.

While the Senate passed the update as an amendment to their version of a jobs bill, the House did not in their version, and the conference committee charged with reconciling the differences between the two left the Updated Bottle Bill out.

Although the Senate is to be commended for passing the update, it was an uphill battle after the Telecom, Utilities and Energy Committee voted 10-7 on June 14 to pass the bill into a "study," effectively blocking its chances.

The TUE Committee voted just two days after a June 12 rally at the Statehouse, where over 100 people showed up, along with our 7-foot mascot, "Bottle Bill," to call on the Legislature to act on the bill. At another Statehouse rally on July 15, emceed by comedian and activist Jimmy Tingle, legislators and supporters came out again asking for swift passage of the update.

The Power of Special Interests

Even though a majority of legislators were on record in support of the Updated Bottle Bill, it became clear toward the end of the session that the majority would not rule. Among those that lobbied against the measure were: Nestle Waters North America, Kraft Foods Global Inc., Coca Cola Bottling Company of New England and other corporate special interests. The result means more litter, less recycling, and tax dollars wasted on trash disposal and litter pick-up.

But we're not giving up. We'll be hitting the ground running when the new legislative session begins in January, to continue the fight for the Updated Bottle Bill.
